- C. Cost of tender document/tender fees (Rs. 750.00) and Earnest Money Deposit ( Rs. 10,000.00 Rupees Ten Thousand Only) will be accepted through GRIPS portal through **State government e-procurement portal** by net banking payment to ICICI Bank Payment Gateway webpage (along with a string containing a Unique ID) in favour of **Deputy Conservator of Forests, Wildlife (HQ), West Bengal, failing which Tenders will not be considered for competition. - D. The EMD will be released to the unsuccessful Tenderers on written application after 15 days from successful completion of all formalities of the tender. The EMD of the successful Tenderer will be released along with the security deposit after successful execution of the work to the satisfaction of the undersigned.
- E. The successful Service Tenderer will have to deposit a "**Security Deposit**" which will be 10% of the Tendered amount which will be accepted through GRIPS portal through **State government e-procurement portal** by net banking payment to ICICI Bank Payment Gateway webpage (along with a string containing a Unique ID) in favour of **Deputy Conservator of Forests, Wildlife (HQ), West Bengal** and sign an agreement with this office within 5 working days from the date of acceptance and communication of the Tender. The Security deposit Money will be released only after satisfactory execution of the works.
- F. The Earnest Money Deposit and Security Deposit will be liable to forfeiture if the said supply/works are not executed to the satisfaction of the undersigned.
